Application for Early Admission to Kindergarten & Waiver of Eligibility Requirement for 2024-2025 School Year

According to Michigan Law, if a child is not five years of age on September 1, 2024, but will be five years of age not later than December 1, 2024, the parent or legal guardian of that child may enroll the child in kindergarten for the current school year if the parent or legal guardian notifies the school district in writing that he or she intends to enroll the child in kindergarten.

The school district that receives this written notification may make a recommendation to the parent or legal guardian as to whether the child is not ready to enroll in kindergarten due to the child’s age or other factors. Regardless of the district recommendation, the parent or legal guardian retains the sole discretion to determine whether or not to enroll the child in kindergarten if the student is five years of age not later than December 1.

Kindergarten Program Age Requirement

Michigan law states that a child must be five (5) years of age by **September 1st** in order to be eligible to attend a kindergarten program for the 2024-2025 school year.

If the child is not five (5) years of age by September 1st (enrollment eligibility date) but will be five (5) on or before December 1st – the parent/guardian may still enroll the child in a kindergarten program for the 2024-2025 school year; **a written statement or age waiver must be included**. The Age Waiver form is an application for early admission and an acknowledgment the parents understand they are waiving the eligibility requirement.

A child with a birth date of December 2nd or later, will be eligible to enroll for a kindergarten program the following school year, 2025-2026.

All enrollments must be completed before any child can attend kindergarten. Parents are encouraged to complete their enrollments for their child as early as possible... by the end of July preferably.
